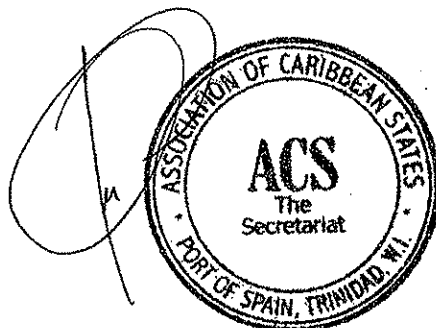

The Secretariat has the honour to refer to the mandates of the 18th Meeting of the Special Committee on Transport, which was held at the ACS Headquarters in Port-of-Spain, Trinidad and Tobago, on 22-23 September 2009 and its communication C.282/2009/LC dated 9 November 2009.

In this regard, the Secretariat recalls the decision of the Special Committee to enhance its efforts to appraise the state of air transport and air connectivity within the Greater Caribbean by conducting a review of one week (the second week of July 2009) of airport traffic information between the airports located *only* in the Caribbean destinations of ACS Members.

The purpose of the analysis is to determine the possibility to travel by air along ACS routes among the Caribbean destinations of ACS Members in 24 hours or less and thus provide invaluable information for analysts and decision-makers in identifying routes that could be developed in order to render such travel possible. In the longer term, the study would indicate the need for a more detailed study and point towards the possible terms of reference for such a study. The Secretariat, therefore, kindly requests the contribution of all ACS Members by the transmission of their traffic information for the relevant airports and for the aforementioned week.

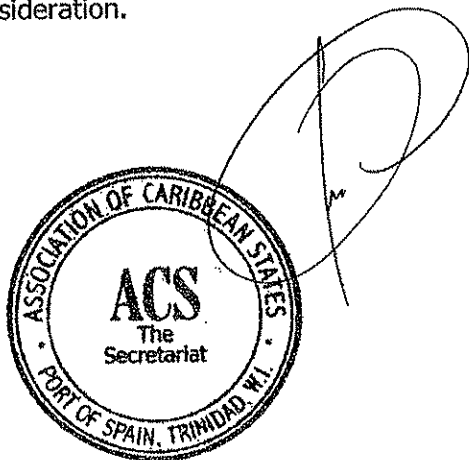
